

The Official Declaration of Intent and Integrity on Administration by The Secondary Education Service Area Office Phitsanulok Uttaradit

The Secondary Education Service Area Office Phitsanulok Uttaradit focuses on administering its duties with integrity and transparency in accordance with the intentions of the Constitution of The Kingdom of Thailand of B.E. 2560 (2017), the Official Information Act of B.E. 2540 (1997), the National Anti-Corruption Strategy Phase 3 (2017-2021) and the 10th National Government Policy "to promote good governance, anti-corruption and good conduct in the state of affairs in the public sector", the Royal Decree on Criteria and Procedures for Good Governance of B.E. 2566 (2023), the Proclamation of the Office of the Basic Education Commission re: The Rules of Public Sevice Ethics under the Office of the Basic Education Commission of B.E. 2552 (2009) dated August 31, 2009, the Integrity and Transparency Assessment: ITA Handbook of the fiscal year B.E. 2560 (2017) of the Office for National Anti-Corruption Commission, and the Proclamation of the Secondary Education Services Area Office 39 on the Code of Ethics for Civil Servants to prevent conflict of interest among government officials dated December 29, 2015.

I would like to express my honest intentions on behalf of the director of the Secondary Education Service Area Office Phitsanulok Uttaradit, that encourages all government officers and personnel to work conscientiously, honestly, and effectively while protecting the interests of the state and providing fairness to all stakeholders.

All officers and I will work effectively with honesty and inteprity, We are determined to protect the interests of the state and provide equality to people, teachers, and educational personnel impartially. I will administer my duties and responsibilities to the office with good governance that is anti-corruption making the Secondary Education Services Area Office Phitsanulok Uttaradit to be the most honest government office there is through the following processes:

- 1. Perform all duties and responsibilities of all personnel by strictly following and working under the law, and all related policies and regulations.
- 2. Foster and raise utmost awareness on anti-corruption values, morality, and ethics in all systems discriminating against personal interests and benefits.
 - 3. Reject comupt behaviors and practices and repudiate all forms of

corruption that cause social punishment that will result in the embarrassment of the personnel and the office.

- 4. Foster and raise general awareness of the disadvantages of corruption to all teachers, students, and personnel under the supervision of the Secondary Education Service Area Office Phitsanulok Uttaradit.
 - 5. Adhere to the following operational guidelines and cooperative activities:
- 5.1 Coordinate and cooperate with various agencies to imolement The National Anti-Corruption Strategy Phase 3 (2017-2021).
- 5.2 Join the network of the Basic Education Commission and the Educational Services Area Offices and supervise schools to prevent and suppress corruption with other offices.
- 5.3 Train and engage all school administrators and educational personnel on moral conduct, ethics, and in the surveillance and investigation against all forms of coruption.
- 5.4 Cooperate and collaborate with other agencies to prevent and suppress all forms of corruption to the best of our abilities.
